sustainable infrastructure development is vital for africa s prosperity and now is the time to begin the transformation this volume is the culmination of an unprecedented effort to document analyze and interpret the full extent of the challenge in developing sub saharan africa s infrastructure sectors as a result it represents the most comprehensive reference currently available on infrastructure in the region the book covers the five main economic infrastructure sectors information and communication technology irrigation power transport and water and sanitation africa s infrastructure a time for transformation reflects the collaboration of a wide array of african regional institutions and development partners under the auspices of the infrastructure consortium for africa it presents the findings of the africa infrastructure country diagnostic aid a project launched following a commitment in 2005 by the international community after the g8 summit at gleneagles scotland to scale up financial support for infrastructure development in africa the lack of reliable information in this area made it difficult to evaluate the success of past interventions prioritize current allocations and provide benchmarks for measuring future progress hence the need for the aid africa s infrastructure sectors lag well behind those of the rest of the world and the gap is widening some of the main policy relevant findings highlighted in the book include the following infrastructure in the region is exceptionally expensive with tariffs being many times higher than those found elsewhere inadequate and expensive infrastructure is retarding growth by 2 percentage points each year solving the problem will cost over us 90 billion per year which is more than twice what is being spent in africa today however money alone is not the answer prudent policies wise management and sound maintenance can improve efficiency thereby stretching the infrastructure dollar there is the potential to recover an additional us 17 billion a year from within the existing infrastructure resource envelope simply by improving efficiency for example improved revenue collection and utility management could generate us 3.3 billion per year regional power trade could reduce annual costs by us 2 billion and deregulating the trucking industry could reduce freight costs by one half so raising more funds without also tackling inefficiencies would be like pouring water into a leaking bucket finally the power sector and fragile states represent particular challenges even if every efficiency in every infrastructure sector could be captured a substantial funding gap of 31 billion a year would remain nevertheless the african people and economies cannot wait any longer now is the time to begin the transformation to sustainable development

the financial crisis inquiry report published by the u s government and the financial crisis inquiry commission in early 2011 is the official government report on the united states financial collapse and the review of major financial institutions that bankrupted and failed or would have without help from the government the commission and the report were implemented after congress passed an act in 2009 to review and prevent fraudulent activity the report details among other things the periods before during and after the crisis what led up to it and analyses of subprime mortgage lending credit expansion and banking policies the collapse of companies like fannie mae and freddie mac and the federal bailouts of lehman and aig it also discusses the aftermath of the fallout and our current state this report should be of interest to anyone concerned about the financial situation in the u s and around the world the financial crisis inquiry commission is an independent bi partisan government appointed panel of 10 people that was created to examine the causes domestic and global of the current financial and economic crisis in the united states it was established as part of the fraud enforcement and recovery act of 2009 the commission consisted of private citizens with expertise in economics and finance banking housing market regulation and consumer protection they examined and reported on the collapse of major financial institutions that failed or would have failed if not for exceptional assistance from the government news dissector danny schechter is a journalist blogger and filmmaker he has been reporting on economic crises since the 1980 s when he was with abc news his film in debt we trust warned of the economic meltdown in 2006 he has since written three books on the subject including plunder investigating our economic calamity cosimo books 2008 and the crime of our time why wall street is not too big to jail disinfo books 2011 a companion to his latest film plunder the crime of our time he can be reached online at newsdissector com
